## 1. Introduction

GrowBIT is a revolutionary blockchain project aimed at solving some of the major challenges in the cryptocurrency space, including slow transaction speeds, limited interoperability, scalability issues, and security vulnerabilities. Our vision is to create a blockchain network that allows the fastest transactions and provides the capability for cross-chain interoperability. The GrowBTC token (GROWBTC) will power this ecosystem, enabling seamless interaction between different blockchains while ensuring high scalability and security. ## 3. Vision and Mission

**Mission:** GrowBIT will develop a fast, scalable, and secure blockchain that facilitates seamless transactions across multiple blockchain networks. Our ICO is the first step in raising the necessary funds to build the ecosystem, including our blockchain and the GrowBIT Swap Exchange.

The distribution will be as follows: **ICO Sale :** 1. Billion Tokens will be available for sale during the ICO to fund the development of the blockchain and the exchange.

**Exchange Listings :** 1.2 Billion Tokens will be allocated for exchange listings, enabling liquidity and market growth.

**Locked Tokens :** 7.8 Billion These tokens will be locked for 15 years, with 6.67% released annually to ensure a steady supply into circulation.

## 7. ICO Structure

The GrowBTC ICO will be conducted in the following manner:

**Duration :** The ICO will run for 3 months, allowing sufficient time for investors to participate

**ICO Launch:** Tokens will be sold via our official ICO website and DApp (Decentralized Application). Investors will be able to participate in the ICO using BTC, ETH, USDT BNB.

**Post-ICO Sale :** After the ICO, GrowBTC tokens will be listed on various exchanges.

## 8. Use of Funds

The funds raised during the ICO will be allocated as follows:

**Development of the GrowBTC Blockchain and Swap Exchange** (including infrastructure, development, and testing) **Marketing and Community Building** (to grow our user base and engage with our community) **Legal and Compliance** (to ensure compliance with international laws and regulations)

**Security and Audits** (including penetration testing, vulnerability assessments, and regular audits) **Operational Costs** (for day-to-day operational expenses such as salaries, office rent, etc.) **Contingency Fund** (to cover unforeseen expenses)

**2027 and Beyond:** Expansion to support more blockchain networks, further enhancements to the platform, and increased marketing efforts.
